



## **ScoreItNow!™ Online Writing Practice Voucher Service**

### **Process for Obtaining ScoreItNow! Vouchers**

Complete the Order Form and Use Agreement on the following pages and return both to ETS.

- Vouchers can be purchased with either a purchase order or a credit/debit card. Payment for purchase orders must be submitted within 30 days of receipt of the invoice.
- Email the completed Order Form to [gretests@ets.org](mailto:gretests@ets.org). **DO NOT** include credit/debit card information on the form. ETS will contact you for your credit/debit card information.
- Upon receipt of the completed form at ETS, vouchers will be prepared for the quantity ordered and sent electronically to the email indicated on the form. Your institution/organization can then distribute the vouchers to students for whom the fee will be paid. Refund requests will not be accepted.
- All vouchers are redeemable for one year from date of issue.
